Treasurer's Report

Treasurer Al Renz distributed the Treasurer's Report for October. Perhaps the most significant item to come from his report is that a rather large number of members had not paid their quarterly dues (due October 1) as of October 31.

Al read the notice he had received regarding the criminal trial of Jeff Klimek. The trial will be held in Federal Court on December 3, but the location of the court was not provided. Al reported that Jeff resumed his bankruptcy payments in October, but that his attorney's fees took more than the payment. Our Club is currently owed \$67,101.72 from Jeff.

Election of Representative to the Optimist Foundation

President Casteel reported that Gay Pepper had already been nominated for this position, and the floor was opened for further nominations. No further nominations were forthcoming, so George McDonough moved that Gay be elected by acclimation. The motion was seconded by Al Renz and passed by unanimous vote.

Committee Reports



Fabiani Duarte that the **Veteran's Day Parade** went quite well considering the inclement weather. Our Club and the JOOI Clubs were merged with Still Serving Veterans. The combined groups had 7 vehicles and 80 volunteers, including JOOI Club members from Grace Lutheran School and Whitesburg Middle School. There were some additional Optimists viewing the parade from the sidelines, as well.

Bob Martin recommended that the Club invest in some banners and/or magnetic signs for both the Club and for the JOOI Clubs for future parades. Being combined with Still Serving Veterans brought no recognition to either our Club or the JOOI Clubs. Alberto Duarte concurred, and added that banners should also be provided to each school that has a JOOI Club. Tom Casteel volunteered to look into sources and costs and report back on his findings.

Fabiani Duarte reported on the rather packed schedule of **JOOI Club meetings** at the various schools (The schedule was included in the last issue of Opti-Topics). One change in the schedule is that the Ed White Middle School meeting has been postponed to November 29. He reported that an excellent meeting was held at Hazel Green High School. Unfortunately, there were not enough Club members in attendance to do any recruiting of new Optimists (for our Club) from among the parents who were there. He urged better representation at future meetings. Several of the new schools have reported that advisors have been named, a critical first step in getting a JOOI Club organized.

The Huntsville City School System has been forwarded applications of veterans who have agreed to be advisors at the various schools with JOOI Clubs. These veterans will assist the schools' sponsors in guiding the JOOI Clubs.
