Program



Vastell Williams introduced our speaker (and his boss) for tonight's program, Tom Rumph, Jr., by saying "Tom needs no introduction because he is a member of our Club." Vastell first Tom when he served as a consultant to Alabama A & M University. Tom is the founder and managing partner of

Rumph and Associates, P. C. Tom had just returned yesterday from a training session in Johannesburg, South Africa.

Tom began his talk by giving a few vital statistics on Rumph and Associates. The company's annual revenue is \$7.3 million. The company's growth over the last 3 years has averaged 200% annually. There are currently 102 people on the payroll. On a personal level, Tom said he is an avid golfer, and he has learned that playing golf with a person is a good way to learn about the person's character.

Rumph and Associates is primarily an accounting firm whose main customer is CDC, the U. S. Government's Center for Disease Control headquartered in Atlanta, GA. The company has offices in Alpharetta, GA, Huntsville, AL, and Johannesburg, South Africa. Rumph and Associates provide a number of services for the CDC in Africa, Central America, and South America.
