Jim announced that our Christmas Party committee recommended that the event take place on Dec. 16th, at the Cooper House where our recent pancake breakfast was held. In addition to offering the facility for this party Hawthorne Conservatory's Director Mary Flynn added graciously that the Cooper House was available to us for fund raising use by our club.

Our next order of business was to elect a Huntsville Optimist Foundation Board member to a 3-year term, starting

A secret paper ballot resulted in Tom being elected. Following the election Clyde expressed his concern that Tom is on the fast track to become the club's next president, and he wondered if it was wise to have a seated

president on the HOF Board. The general feeling of the club was to deal with any appearance of a conflict of interest, later.

Wintzell's Oyster House will give us \$10-off coupons that we could sell. Rocket City Bar-B-Q has a Boston Butts deal, and Logan's Roadhouse offers celebrity table waiting.

Tom Casteel recently made an analysis of the club's financial status and concluded that although our \$110 per quarter dues barely meets expenses (and would have to be increased if everyone attended regularly), it is a formidable roadblock in recruiting new members. He brought up the deal of charging reserved members \$30 per quarter with the stipulation that they pay for meals when they attend. Currently to qualify as a reserved member 10 years of membership is required. Tom and others would like to push for a similar deal in recruiting parents of JOOI Club members. He moved that our by-laws be amended to allow for this. Alberto seconded and it passed. Hopefully, these ideas will be thought about and be aired again at the Dec. business meeting and some conclusions drawn.
